

Dear Band Management or Artist(s),

Planning has begun on the 30th Thoughts for Food benefit event for the Racine County Foodbank.

At the moment, we are going forward with what will be a somewhat abbreviated "live" event; with a few less venues and bands due primarily to some venues not signing up for the event this year. This is quite understandable considering the pandemic and its associated issues. This may change, however.

We cannot forecast the severity of the pandemic and its restrictions, if any, at the time of the event. As such, we are also planning for a video recording session, similar to the one done last year, if situations warrant it.

To that end, we would like this application/waiver to serve as not only proof of your interest and volunteering for the live event, but for the recording session if you so desire. If you would rather not do one event or the other, you will have the opportunity to make that known on the application/waiver as well. Additionally, we are planning on having a live streaming of a few, select groups on the day of the event, if held, at the Ivanhoe, starting earlier in the afternoon. There will be an opportunity to make your interest known in that event as well on the app/waiver.

If there is a live event, it will be held on March 5, 2022, in Downtown Racine and the River North area. If there is to be a video recording rather than live playing, it will be done sometime in January/February, on a weekend. As with last year's recording, bands will be given a DVD or thumb drive of their performance, plus it will be posted on YouTube for all the world to see and enjoy.

We apologize for the fluidity of the event at this time, but we simply don't know where this pandemic is taking us. We do know, however, that whatever is done will be fully under the auspices of the City of Racine and Health Department guidelines. Neither the Racine County Foodbank nor this committee will be responsible for or contribute to the spread of the Covid-19 virus in this city.
